Wedding Photography Terms of Agreement

It is agreed that the terms set out in this booking form is the total agreement made between the parties and that no variation or modification of this contract shall be effective unless agreed by both parties in writing.

1. Payments

Following payment of the booking fee, the balance of fees is to be paid no less than 28 days prior to the wedding. No further services will be rendered until all payments due have been paid in full. Payment for additional images is to be made when they are ordered.

2. Reorders

All reorders shall be treated as an extension of this contract and no responsibility for errors will be accepted unless orders are given in writing.

3. Special Requests/Coverage

The client understands and accepts that the photographic coverage will be as the photographer's professional expertise determines and that no one photograph will be deemed more important than another. Special requests are not binding instructions although every effort is made to comply with the client's wishes. Any special requests not notified on this booking form must be made by the client, in writing, to Louise Wynne Photography.

4. The Photographer

On occasions and without notice it may be necessary for the photographer originally specified to be substituted by another photographer (e.g. due to ill health).

5. Images

All image sizes are nominal. Louise Wynne Photography will attempt to provide a pleasing colour balance but cannot guarantee exact colour matching owing to anomalous reflectance caused by a combination of certain dyes and materials especially man-made fibres.

6. Retouching

Retouching, digital manipulation and artistic finishing is available to the client as an optional extra unless stated otherwise in this contract.

7. Copyright

Any images or copies of images whether stored digitally or otherwise and any computer program including any source or object code, computer files or printed documentation relating to such images are protected by the Copyright, Design and Patents Act 1988. It is contrary to the Act to copy or allow to be copied photographically/electronically or by any other means an image created as part of this contract without the permission, in writing, of Louise Wynne Photography.

8. Digital Files

Digital files remain the property of Louise Wynne Photography.

9. Licence

Louise Wynne Photography shall be granted complete artistic licence including in relation to the poses photographed and the locations used. The photographer's judgement regarding the location/poses and number of images taken shall be final. Due to the vagaries of the weather and the willingness of subjects it may not be possible to capture all the images requested.

10. Force Majeure or Act of God

The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control.

11. Previews

Although Louise Wynne Photography will do their best to produce more proofs/preview prints as discussed with the client, there is no guarantee that any particular number of proofs/preview prints will be produced.

12. Display

The client hereby allows Louise Wynne Photography to display any images included in this contract in their studios, portfolios, literature, wedding exhibitions, websites and advertising. No use of the images will be made by Louise Wynne Photography for other commercial reasons except with the written permission of the client.

13. Cancellation

The client may cancel this contract at any time by giving written notice to Louise Wynne Photography but in doing so will forfeit any monies paid. Should cancellation be received by Louise Wynne Photography less than 12 weeks prior to the date of the ceremony, the client shall in addition pay a sum equal to the balance of the monies owed as stated in the contract. The said sum shall be payable as compensation as an estimate of the loss that Louise Wynne Photography would suffer. Weddings that are postponed to a later date will retain the fee as long as Louise Wynne Photography can reschedule for the new date and time.

14. Limitation of Liability

In the unlikely event of a total photographic failure or cancellation of this contract by either party or in any other circumstances the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.

15. Complaints

Any complaints should be raised by the client with Louise Wynne Photography in writing within 28 days of first becoming aware of the matter to be complained of and in any event within 28 days of receipt of the images.
